## THE US VACCINATION IS A SUCCESS BECAUSE THEY DREAM BIG & WE MUST TAKE RISKS

**USPA NEWS** - EU leaders have met via video conference to take stock of the COVID-19 epidemiological situation, and particularly over the vaccine on 25 March 21, (Initially scheduled 25 and 25 March 21, has been shorter to the 1st day). President Macron held a press conference at Elysee Palace, before only four journalist, relaying the event, over a live facebook for the rest of the accredited journalists. President Macron acknowledged that the USA has been more reactive with regard to vaccine management against COVID-19 and has allowed itself ambitious dreams, towards the European Union, "We reacted less quickly than the United States, it is a fact, but not a failure" He also admitted at least that the European Union has a strategy and a vaccination diplomacy " It is the only continent of the free world which has a vaccination strategy and a vaccination diplomacy " He also announced that the European Union will be the continent of the Free World which will produce the most vaccines in the coming weeks. "We published all the exchanges between President Macron and the four journalists present at the press conference, who, mainly focused on the vaccine strategy in France versus the European Union.

PRESIDENT MACRON ANSWERING TO THE QUESTION OVER "NOT LOCKING DOWN BY THE END OF JANUARY, AND IF HAVING REGRETS IN ORDER TO FIGHT AGAINST COVID-19 -----

"The key is to correct these effects of the circulation of this virus. Should we have confined on January 29, as many models have said, predicting an outbreak in February? We have had the collective experience of it, NO, so we were right not to report at the end of January, because it is not just the explosion predicted by all models. So I have no mea culpa or any regrets or any acknowledgment of failure and we were right to do so because the zero virus risk does not exist and does not exist in any country in Europe. With the braking measures we had in place, we were able to prevent an outbreak of the virus. Then from March 8-10, there was an inflection, which was reflected in the incidence rates and then observed in hospitalizations and resuscitations. And that's when it started to accelerate in terms of virus circulation, due to the British variant which has become the majority in each department. We then adapted our rest by adding additional braking measures to strengthen the "TEST-ALERT-PROTECT » and last week, the government implemented additional braking measures, including the strengthening of telework (set out by the Minister of Labor ) and social conditions in about twenty departments. It's pragmatism. We must take into account several factors, the dynamics of the virus, the other pathologies that are still there, and mental health, especially for social life and in particular for our young people, for whom the situation is difficult to live with and our educational priority. . So when we close everything, it has both economic and social consequences and it is a balance that we must keep in balance. I therefore repeat that we were right not to close on January 29 and subsequently to take braking measures and depending on this epidemic, by adapting ourselves and we identify all the useful measures in due time. In my opinion, there are no taboos and always have the right rest-----

We must all have a lot of humility, kindness and patience. That's why I wanted to explain how we did it and today I am watching the situation very carefully. Our emergency services are under very strong pressure and in the coming days and weeks we will continue to carry our most fragile fellow citizens, who are arriving in intensive care. To protect our caregivers as well, to enable them to face this challenge again, and to do so in working conditions that I already know are difficult, we will do everything to help them with the sanitary reserve and the additional means and never them. confront ethical shits. And to continue to burp els other patients, in France in particular those who have treatments but also to take into account these other dimensions that I mentioned, ie mental health, fatigue that exists in the country, the health of our young people, of our children and the need to educate them and allow them to be in a framework of development and the economic and social situation of the country. No doubt that in the coming days and weeks we will take new measures together in the light of the facts by being transparent and in real time. I would like to give you not a ray of hope but a reasonable prospect of hope. We are going to pass several steps" » President Macron acknowledged

BY MID APRIL WE WILL HAVE VACCINES 10 M OF FRENCH AND WILL BE IN COLLECTIVE PROTECTION BY APRIL

Present Macron, answers the Journalist over the vaccine rollout in France, which happens to be still very slow, despite all efforts deployed by the French sanitary authorities. Yet, the French head of state is still optimistic for the future as he unveils the road map for vaccinating in France, as the vulnerable people are the 1st served : "By mid-April we will have vaccinated 10 million French people, the oldest and most vulnerable, which means that 10 to 15 days later they will be protected. And it is the majority crush of our fellow citizens that we find in the intensive care units. Apart from April 20, we will take a step forward thanks to vaccination in terms of collective protection. Then we will continue to vaccinate more and more, because of the supply that will increase in load been we will have, in mid-May 20 million of our fellow citizens who will be vaccinated, ie those I mentioned earlier and the slice of age that follows, and 30 Million in mid June. This will allow us to take the pressure off hospital reanimation services and to return in the weeks of late April and May to stages that I will try to describe to our fellow citizens. It is a question of finding a course not because we will have regained control of time, but because we will have control of the virus thanks to the vaccination. These coming weeks will be difficult, but our outlook on immunization must lead us to do so together with great spirit, responsibility, and mutual respect. President / macron told the reporter about collective immunity. "

QUESTION JOURNALIST: YOU HAVE RECOGNIZED EUROPE'S FAILURE IN THE VACCINE RACE OF LACK OF REACTIVITY AND AMBITION AT THE START AND WHAT DO YOU MEAN BY LEARNING FROM THIS? AND DO YOU RECOGNIZE A FAILURE OF YOUR HEALTH POLICY AT THE NATIONAL NEWS AS THE EPIDEMIC---- EXPLODES WHILE DOCTORS QUALIFY YOUR ATTITUDE OF ENTITLEMENT TO TAKE HARDER MEASURES?

ANSWER PRESIDENT MACRON : "I haven't expressed any form of failure, I know we tend to like mea culpa, but you have to be clear-headed. Many people think that when you are willing you should not recognize the situation as it is. I try to be clear-headed. We reacted less quickly than the US, that's a fact. Having said that, I don't admit a failure because we have corrected this delay, yes we did have a delay that's true. If I did not say it today, you would tell me that I am rightly lacking in clarity, and that made the comments I am going to make later less credible.-----

First we recognized it and repaired we set up an export control service, we are no longer naive. And then, secondly, we recognized and fixed it and then we agreed to step up (vaccine) production in Europe. Third and above all, I want to stress one point, the European Union has implemented a large-scale industrial production policy for a capacity of 2 to 3 Billion doses per year, by the end of the second half of 2021. This means that we will not only be able to not only meet our own needs but also to export on a massive scale. This means that after having met our European needs, we will export 300 M of dose in the 1st quarter. After 420 Million at the end of July. This will allow us to achieve our continental collective immunity which will put us in mid 2021, to be able to produce enough for ourselves and to protect our fellow citizens with our collective immunity. Europe is the only continent which is capable of producing and exporting, according to the figures I have just mentioned. It is the only continent in the free world that has a real vaccine strategy and vaccine diplomacy, not to blackmail this or that country. It is our international commitment We must be very clear, we are facing a war of a new kind, facing the attacks and inclinations of Russian destabilization, Chinese influence by the vaccine, facing this if we want to hold on, we must be sovereign. In the coming days, I will have the opportunity to open production sites in France, which come to commit other French sites installed all over Europe. Faced with this lucidity that I mentioned earlier, I think alone we have caught up with the delay and that we are in the process of responding to this crisis.

By the end of this summer, Europe will be the continent which will produce the most vaccine doses in the world, the continent which is able to protect itself as a woman and to export her more via its partners in the NATO of the free world, and for all who need it. Its very important.

We are also in the process of building the capacity to produce the tenth generation vaccines, "is also at least as important. In the fall to winter at the beginning of the year we will probably have new variants of this virus, and these variants will again lead to a new vaccination strategy. Our fellow citizens must know this and there, we must go very quickly by vaccinating, even faster to protect ourselves against this virus, which will continue to circulate to mutate, and we will have answers to provide. What we are doing is also to build capacity as quickly as possible in Europe, with these changes and that is very important. On the French strategy, vaccines, we must be humble in the face of an epidemic. " Pdt Macron stated,

QUESTION JOURNALIST : DURING AN INTERVIEW ON GREEK TV, YOU, PRESIDENT MACRON, MENTIONED TURKEY INGERENCE IN PRESIDENTIAL ELECTIONS WHAT DID YOU MEAN? AND HOW TO PLACE THIS COMMENT IN A CONTEXT OF A FOUNDED DIALOGUE BETWEEN THE EUROPEAN UNION AND TURKEY? AND DO YOU THINK THAT THE EU SHOULD SPEND AS MUCH IN VOLUME AS THE AMERICANS ON THE RESCUE PLAN?-----

ANSWER PRESIDENT MACRON : "There is nothing inexplicable or to be explained about what I said about Turkey, it is a fact. Today there is the existence of community organizations, which have been clearly explained and implemented, of continuous groups, of politicized, Turkish groups on the European continent, which are today active by propaganda bodies. officials from Turkey, and among others. They are entrusted and operate in Germany as in France, sometimes they mule our elections, other times they get involved in

funding associations. We saw them following the legitimate alerts of the Minister of the Interior, with regard to some territorial collectives, perhaps a little too complacent. When we have associations that recognize that they are unable to adhere to the values “of the republic, that is a problem. It is a form of interference in our republic, There is also another form of interference with propaganda organizations that broadcast on their channels, also it is identified, we observed it last fall . So, yes the risks of interference are identified, for the presidential election deadlines, just as the risks of disgrace have been identified in other countries of Europe, because they are organized and structured. This is a problem and you can't take a friendly relationship if you don't tell each other things, to sort them out. France has no propaganda tool, it does not finance associations, religious structures that operate in foreign countries, or participate on behalf of France in foreign ays. You would be shocked if it existed. It is normal that we are in a democracy. The frankness is required and we have to fix it. Regarding the recovery plan, I want to be clear, the amounts are not comparable, because in the United States, there are no safety nets that exist in Europe and particularly in France. There is no current operation, redistributions of our public policies which are in a way the equivalent of public expenditure which is redistributed and which is also a response to the crisis. So we can't compare everything. There is a lot of demand in the American stimulus plan, not supply, which compensates for the lack of solidarity in normal times in the United States of America. " President Macron said

WE MUST DRASTICALLY SIMPLIFY OUR RESPONSES IN EUROPE & FRANCE BECAUSE WE ARE TOO SLOW AND TOO COMPLEX AND BURDEN IN OUR BUREAUCRACY" PRESIDENT MACRON STATED----- : President Macron then recognized the slowness of the bureaucracy in the smash and the European way, too complex, which deserves to be simplified: "The figures were made public by the OECD and the ECB and the difference is less, between the American and European Recovery Plan, however, there is a difference, and when I look at the trajectory over the coming years, we can clearly see that the United States will return to their absolute level and their pre-crisis trajectory by mid 2021. crisis. We will return to this level in the spring of 2022, with a shift in trajectory which is worrying, because it is a rye of potential growth and that supposes a more vigorous response.I think that it is this discussion that we must have between Europeans: How to improve this response, how to invest faster and stronger on sectoral priorities, and beyond the amounts of investments, I believe very deep and this is one of the lessons of the crisis for Europe and France we need drastically simplify our responses. We are too slow, too complex and bogged down in our bureaucracy. We have been through it, we have to go faster and harder, this is a lesson we have to learn. "
